Random Moment Time Study (RMTS)
Mandatory Annual Training for MH/IDD

RMTS annual training is mandatory for all Mental Health/Intellectual and Developmental Disability (MH/IDDs) that wish to participate in the Medicaid Administrative Claiming (MAC). Training sessions are conducted by the Texas Health and Human Services Commission (HHSC).

It is crucial MH/IDDs understand that compliance with the RMTS annual training requirement is mandatory. Failure to comply with this requirement will impact the MH/IDD's ability to draw federal funding for MAC. In addition, MH/IDDs will not be given full access to STAIRS the online time study system for FFY 2016 until the annual training requirement is met.

"Initial versus Refresher"

Training requirements can be met by one of two methods. RMTS Contacts who have never attended RMTS MH/IDD training must attend "initial" training. Those who have attended an initial training may attend either initial or refresher training. See above website for additional details.

The training for RMTS Contacts is held separate from the training for MAC Financial Contacts. Training for the MAC Financial Contacts will be offered closer to the actual

financial reporting periods. Although an overview of the MAC Financial will be provided during the RMTS training, it is mandatory for the MAC Financial Contact to attend the separate MAC Financial training in order to have access to the online financials.
